Single Parent household and those who need to apply. Inquiry: Kodomo Mirai-ka (AIAI, TEL: 0595-96-8822)

Payment amount: 20.000 yen/per child

Need to Apply: People who have not received Child Rearing Allowance(Jidō Fuyō-teate) for November 2023, those who are not eliqible for Child Rearing Allowance(*Jidō Fuyō-teate*) for November 2023, and those whose household finances have suddenly changed due to the effects of soaring prices such as food expenses, etc. **Application deadline: February 29th (Thu), 2024**

### [Non-Single Parent household and those who need to apply]

Inquiry: Shimin-ka (TEL: 0595-84-5005)

Payment amount: 20.000 yen/per child

Need to Apply: People who are exempt from resident tax in the fiscal year of 2023, and people whose household finances suddenly changed after January 2023 due to the effects of rising prices such as food expenses and whose income is equivalent to exempt from resident tax.

Eligible children: Children born between April 2nd, 2005 (April 2nd, 2003 for children with disabilities) and February 29th, 2024

Application deadline: February 29th (Thu), 2024 \* If you have any questions, please contact Shimin-ka.

Resident tax-exempt household priority support benefit [住民税非課税世帯重点支援給付金]

Inquiry: Chiiki Fukushi-ka (AIAI TEL: 0595-84-3311)

Kameyama City will provide priority support benefits of 70.000 yen per household to tax-exempt households from resident tax. (Limited to once per household)

Households that have a resident card in Kameyama City as of December 1st, 2023, and where all members of the same household are exempt from resident tax for the fiscal year 2023 (however, households where all members of the household are not subject to resident tax)

Households that need to apply: Households whose household status has changed since June 2nd, 2023 (e.g., the head of the household moved out or died), Households that moved to Kameyama City after June 2nd, 2023

For those who are evacuating due to spousal violence

Those who have evacuated due to spousal violence and who were unable to move their resident card to Kameyama City before the reference date (December 1st, 2023) due to circumstances, must meet certain requirements. If you meet the requirements, you can apply for benefits by submitting an application form.

### **Where you can file a Final Tax Return** [税の申告の案内(確定申告)]

Inquiry: Suzuka Zeimusho (TEL: 059-382-0353)

Final tax return is the process of correctly calculating and confirming the tax (income tax) you pay to the country. If you have paid too much tax (income tax) to the country, you will receive the tax back, and if you have not paid enough, you will need to

You can make an appointment in advance. You will be required to get "Nyūjō Seiri-ker" (Admission tickets), without any appointment. You can get it in advance from QR code (LINE App) but only available in Japanese.

\*There is no interpreter at the place, we recommend you to go with someone who can understand in Japanese.

#### [Who needs to submit income tax returns]

People who have income of more than ¥200.000 other than salaries or those who have two or more jobs, etc.

#### [Where you can consult about tax returns]

Place: AEON Hall (AEON MALL SUZUKA) 2nd Floor Period: February 13th (Tue) - March 15th (Fri)

Open Hours: From 9:00 a.m. to 5:00 p.m. (Monday to Friday, Reception ends at 4:00 p.m.).

From 9:00 a.m. to 10:00 a.m. Only the South Entrance (near Saizeriya) will be opened.

- If many people visit there in a day, the reception will be closed earlier without any notice.
- · From February 16th (Fri) to March 15th (Fri), they will not teach you how to make the documents at Suzuka Tax Office.

If you have an address (resident record) in Kameyama City as of January 1st, 2024, but have not filed a final tax return or are not receiving a salary, etc.

This declaration can be made at Kameyama City Hall.

Period: February 16th (Fri) to March 15th (Fri)

\*People who file income tax returns do not need to file city/prefectural tax returns.

### National Health Insurance tax will be reduced during the prenatal and postnatal period. [産前産後期間の 国民健康保険税が軽減されます。]

#### Inquiry: *Shimin-ka* (TEL:0595-84-5006)

If you are a National Health Insurance member of Kameyama City and due date or have given birth, your National Health Insurance tax will be reduced during the pre- and post-natal period. An application is necessary to receive the reduction.

Eligible person: After November 1st 2023, People who are planning to give birth or those insured by

Kameyama City National Health Insurance who have given birth.

Reduction period: 4 months in total (6 months in the case of multiple pregnancy) from the month before the due birth date or the month of the birth date.

Redution amount: The amount varies depending on the person.

Required items for application: Identity verification docments (My Number Card, Zairyu Card, etc.),

My Number Confirmation Documents, Maternal and Child Health Handbook

How to apply: Please submit the application documents provided at the counter to Shimin-ka or Seki Branch Chiiki Service Office. \*Please contact Shimin-ka (0595-84-5006) for more information, such as reduce amount and when filing a notification after giving birth.

# Tax due date in February [2月の納税]

Please pay the following taxes and premiums. Deadline: February 29th (Thu)

- The 4th payment : Kotei Shisan-zei / Toshi Keikaku-zei (Fixed property tax/City planning tax)
- The 6th payment: *Kaigo Hoken-ryō* (Nursing Care Insurance Premium)
- The 8th payment: Kokumin Kenkō Hoken-zei (National Health Insurance Tax)
- The 8th payment: Kōkikōreisha Iryōhoken-ryō (Later-stage Elderly Healthcare Insurance Premium)
- \* We recommend direct debit for payment of tax, etc. which is convenient and reliable.
