

## [Eligible Children]

- ① Children who can receive the child allowance for September, 2021.
- ② High school students or the same age children as of September 30, 2021 (born between April 2nd, 2003 and April 1st, 2006)
- ③ Eligible children (new born babies) who can receive the child allowance and born by March 31, 2022.
- X Except the children whose guardian's income in 2020 was higher than the income limit of the child allowance.

- **[Eligible Recipients]** Guardian with the highest income of eligible children (1), (2), (3) above
- [Payment Amount]  $\ge 100,000$  per eligible child
- [Receiving Account] The account in the name of the applicant
- [Payment Period] From the end of January, 2022, payments will be transferred as soon as judgement is completed.

## [Necessary Documents]

- Common documents : Copy of Bank book or Cash card
- Guardian who is rearing High school students or the same age children (People who do not have Resident registration in Kameyama city as of January 1st, 2021): Original of 2021 year (for 2020 year) Municipal taxation certificate or original of tax exemption certificate
- Following people who live separately from children :
  - Original of Residence certificate or Removal residence certificate
  - High school students or the same age children whose residence certificate address is in outside of Kameyama as of September 30th, 2021.
  - · Children born after September 1st, 2021 and whose residence certificate address is in outside of the city
- ★ Benefits will be paid by the municipality which has the guardian's address. Even if the address of the child is in Kameyama City, if the address of the guardian as of September 30th, 2021 is in another municipality, apply to the latter municipality.
- ★Even if you don't know your exact income, apply first.
